reveals Cambridge FT Chief Executive Steps down	Cambridge FT chief executive steps down  HSJ £ reveals that the chief executive of Cambridge University Hospitals NHS Foundation Trust has stepped down with immediate effect after almost three years in post. Dr Keith McNeil announced his resignation yesterday, and the director of finance, Paul James, has also announced that he will leave the trust after a year in post. Dr McNeil joined the trust in November 2012. The trust's director of workforce, David Wherrett, will take up the role of acting chief executive while the trust works with Monitor to recruit an interim chief executive. It is understood a Care Quality Commission report on the trust is due to be published next week, following an inspection in April. Dr McNeil said: "This has been a very difficult decision, but I have decided to step down as chief executive. It is a matter of public record that we face a number of very serious challenges here in Cambridge, including a growing financial deficit, and I feel the time is right to have new leadership in place". Trust chair Jane Ramsey thanked Dr McNeil for his efforts, saying he has shown "great leadership qualities and has helped the trust maintain its reputation for high quality care and excellent outcomes for our patients".	
NHS Providers Todays Health News - reports London trust to recruit 200 physician asosociated on behalf of 40 providers	reports that 200 physician associates will be recruited by Hillingdon Hospitals NHS Foundation Trust on behalf of over 40 trusts across the country. The trust has been asked to manage the recruitment process for the two year initiative by the National Physician Associate Expansion Programme, and it is hoped an increased number of associates will help trusts tackle their workforce shortages and retention difficulties. Physician associates are educated to degree level and have two years of postgraduate training. Their education focuses mainly on general medicine rather than speciality care, they work under the direct supervision of doctors, and are trained to take medical histories, perform examinations, diagnose illnesses, analyse test results, and develop management plans. It is expected that the majority of the candidates will come from the US because of the level of experience required. It has been decided to put one trust in charge of the recruitment to act as a central point of contact for applications and to ensure consistent communications with US recruitment companies. It is also seen as a cost effective way to recruit because it prevents duplication across different providers.	
NHS Providers Todays Health News - reports Warning that nurse immigration rules 'harm patient safety'	Leading NHS figures have warned that "stringent" immigration rules are preventing them from hiring enough nurses in time for winter, reports the BBC. The heads of 10 trusts, along with NHS Employers, have written to the home secretary to say patients are being put at risk, saying that operations might be cancelled unless nursing is listed as an occupation with official shortages. NHS Employers believes that 1,000 certificates of sponsorship, which allow nurses from outside Europe to work here, will be needed in the next six months, adding that "large numbers" of applications have already been rejected. NHS Employers chief executive Danny Mortimer, said: "These are nurses who've been recruited and could start work in the NHS shortly - but we can't get them into the country". He added: "Their absence will be keenly felt. We are asking Theresa May to relieve the pressure on already stretched services as we head into the winter months".
