Chair's reflections

As you would expect, the Trust continues to be under significant pressure as a result of the ongoing Covid-19 pandemic. As we continue in Winter, we remain very grateful for the continued dedication and compassion shown by colleagues across Sherwood Forest Hospitals and for the support from patients and families as they adapt to help us to keep our care safe.

As a Board, part of our role is to provide challenge to the Trust's leadership so that we are collectively focusing on the right things for patients and for colleagues. We have those open conversations on a regular basis and we are assured that the Trust is taking a balanced view and is making considered, practical and compassionate decisions during this very challenging period.

We know that this will be a time of concern for many patients and colleagues, so I am pleased that we are continuing to communicate regularly with the community. The Trust broadcast another public Q&A session last week, and is writing to our community on a weekly basis.

I hope that colleagues feel well supported at the moment and are aware of the channels open to them to raise any issues or concerns, including through our Freedom to Speak Up Guardian.

We are now approaching Christmas and recent Government announcements have given some clarity on what that will look like, although I know this will not be like other Christmasses. At the time of the Board meeting, we will have moved back into Tier 3 and I would encourage everyone to continue to act responsibly and within the Government guidelines. We will get through this by working together.

Elsewhere there are still successes to celebrate, and I update below on both the Trust's annual awards, and our success in being shortlisted for prestigious national awards. Well done to everyone involved. My thanks also to everyone who has had their flu vaccination and to all of those who have completed the annual staff survey. We have had a very good response to both, particularly bearing in mind everything else that is happening

Thank you again to all of our colleagues and partners for everything that you are doing.

North Nottinghamshire NHS stands together to tackle violence, aggression, bullying and harassment towards colleagues

One of the topics that we keep returning to as a Board is supporting colleagues and making sure that Sherwood Forest Hospitals the best place to work that it can be.

I was pleased to see this month that we have led on a new internal and external campaign to tackle violence, aggression, bullying and harassment against NHS colleagues in North Nottinghamshire.



The campaign was delivered during National Anti-Bullying week (16-20 November) and focussed on case studies from NHS staff who have unfortunately experienced violence and aggression whilst doing their jobs. Our aim is to make people think about their actions towards NHS colleagues who are here to help and not be harmed and to let the public and our colleagues know that we are standing together as an organisation against violence, aggression, bullying and harassment.

Our colleagues are always here to help and not be harmed physically or verbally in any way whilst they are at work and we have a zero tolerance approach to abuse of any of our colleagues.

Thank you to the colleagues who have agreed to feature in this campaign and share their experiences.

Awards success

It is covered in more detail in Richard's CEO report, but I want to add my congratulations to all colleagues for the trust being shortlisted for the HSJ Awards' Acute or Specialist Trust of the Year for the second year running. This year has been more challenging than perhaps any other, and we can be very proud that we are again recognised for the progress that we are making and for the care that we are delivering.

We are also shortlisted for the Staff Engagement award at the same ceremony, and our partners Connected Notts are in the running for the Digitising Patient Services Initiative category.

It is a great success to be nominated for these awards in a very competitive environment. I wish everyone luck for the final ceremony in March.

Last month we also had two teams who were runners up in the HSJ Patient Safety Awards. Congratulations to the teams who were shortlisted for the Safety Culture programme, Improving Care for Older People Award, and for the End of Life Care award.

Future of Integrated Care Systems (ICSs)

NHS England and Improvement have shared with systems a document on the future role and legislation for ICSs including 'next steps to building strong and effective integrated care systems across England'. The document builds on previous publications that set out proposals for legislative reform and is primarily focused on the operational direction of travel. It opens up a discussion with the NHS and its partners about how ICSs could be embedded in legislation or guidance. Decisions on legislation will of course then be for Government and Parliament to make.

It builds on the route map set out in the *NHS Long Term Plan*, for health and care joined up locally around people's needs and signals a renewed ambition for how we can support greater collaboration between partners in health and care systems to help accelerate progress in meeting our most critical health and care challenges. We will continue to follow progress with interest.
