Chair Report

Chair's reflections

When I have been in the organisation, or spoken to colleagues over the last month, it has been absolutely clear how busy our teams are at the moment. Colleague wellbeing remains a major focus for the Board and I thank everyone for their continued resilience and commitment.

I recently had the pleasure of meeting a number of colleagues within Medirest; without always getting the limelight this group of colleagues is absolutely essential to the running of our hospitals, particularly during the course of the Covid pandemic. You are all part of the SFH family and I want to thank you for everything you do.

Since our last Council of Governors meeting we have seen the further relaxation of some of the national Covid restrictions as part of the Government's roadmap. We know that it remains as important as ever to maintain our infection control measures and behaviours within our hospitals, to protect vulnerable patients, colleagues and our services. I'm pleased to see this has been clearly communicated.

I was also pleased to see the strong stance the Trust has taken this month in response to a rise in instances of verbal and physical abuse of colleagues. It is unacceptable for anyone to come to work fearful of the abuse they may be subject to and it is important that our colleagues know they have our full support.

This month we have continued to see wonderful donations from our community and colleagues, including members of the community donating to our Covid Response Fund, the donation of £3,500 which was utilised to purchase play stations and games consoles for W25 in appreciated of good care from a grateful family, and the donation of £600 to ICCU in memory of a loved one.

The Charity also led on the installation of three commemorative art installations to recognise and capture the Covid efforts from colleagues, volunteers and community support.

As always, my thanks go to everyone for their hard work and compassionate care.

Richard Mitchell appointed Chief Executive at University Hospitals of Leicester

As you may well be aware by now, following four years as Chief Executive at Sherwood, Richard Mitchell will be leaving us in the autumn to take up a new role, as the Chief Executive at University Hospitals of Leicester.

Richard joined us in June 2017 and he will continue at Sherwood until the end of September 2021. Paul Robinson, Chief Financial Officer and Deputy Chief Executive, will be Interim Chief Executive and he has increasingly started to take on duties from Richard as part of a structured handover.

I want to take this opportunity to thank Richard publicly, on behalf of our Board, our colleagues and our patients for his leadership over the past four years and his commitment to helping Sherwood to continuously improve and to become a truly great place to work and to receive care.



We will all miss Richard, but I congratulate him on his new role and I am sure he will be a great success at Leicester. He is leaving Sherwood in safe hands, with a strong leadership team, strong relationships with our partners and clear plans for continued growth and improvement.

Although Richard will be at the board meeting in September this will be his last Council of Governors so I take this opportunity to thank Richard on behalf of the Governors . I am pleased that he remains as part of our regional NHS family.

Appointment letters available online for Sherwood Hospital patients

Patients at Sherwood Hospital NHS Foundation Trust can now securely access their outpatient letters and appointments electronically via the NHS App.

The new service, which is completely free, will link hospital information in the NHS App, allowing patients to view their hospital outpatient appointment letters. It will also allow patients to add information to their record, for example measurements, symptoms, or data from devices such as fitness watches.

It's all thanks to some extra technology that has been added to the app for patients in Nottinghamshire through Connected Nottinghamshire, which supports the development of digital NHS services for patients across the county.

The NHS App already allows patients to see their vaccinations status, order repeat prescriptions, book and manage GP appointments, get health information and advice, and view their NHS Number and GP health record securely.



The Trust will be writing to outpatients giving them the opportunity to sign up for the new service as they receive appointments, but anyone can sign up at any time. They just need to download the NHS App, click on 'messages' and sign up the service, which is run by NHS partners Patients Know Best. For more information visit https://www.nottsnhsapp.nhs.uk/

High-tech Gamma Scanner's first patient following fundraising appeal

Last month the first patient was able to benefit from the Trust's new Gamma Scanner following a two-year appeal to raise £490,000 to fund the new piece of equipment.

Huge thanks go to the Trust's charity for running the appeal, and of course to the many donations from volunteers, the local community and colleagues.

Primarily used to identify cancerous tumours in patients, the machine revolutionises how patients are diagnosed and treated. The kit can also be utilised for identifying bone and joint issues, as well as sourcing internal bleeding and injuries. In addition, the advanced piece of equipment is able to take two scans at once, a gamma scan and CT scan, condensing patients' appointments and wait time.

The top-spec machine scanned its first patient during National Volunteers' Week, a period of celebration and recognition for all volunteers and their service across the country. Sherwood's volunteers were particularly central to the appeal's success as profits from the Daffodil Café, ward trolley services,



fundraising stalls and events resulted in a donation of £296,000 on behalf of Sherwood's volunteers: more than 50% of the target.

Following the Gamma Scanner appeal, the Trust's latest appeal supports an enhancement to the end of life ward facilities that will enable Sherwood staff to deliver high quality care for patients in the last days of life.
