



TERMS OF REFERENCE

Constitution	The Board of Directors hereby resolves to establish a Committee of the Board to be known as the Audit and Assurance Committee.
Membership	Three Non-Executive Directors one of whom shall be nominated as Chair and one as Deputy Chair and one of whom should have recent relevant financial experience.
	The Chair of the Committee shall be appointed by the Board of Directors.
	The Chair of the Trust shall not be a member of the Committee.
Attendance at Meetings	The Chief Financial Officer, Director of Corporate Affairs, Internal Auditors, External Auditors and Local Counter Fraud Specialist will attend a minimum of two committee meetings per year.
	The Chief Executive shall be invited to attend if required when the Committee considers and approve the Internal Audit and Counter Fraud Plan.
	All other directors shall be invited to attend, particularly when the Committee is discussing areas of risk or operation that are the responsibility of that director.
AACWP53	There should be at least one meeting a year, or part thereof, where the external and internal auditors attend without management present.
Role	The Audit and Assurance Committee's principal purpose is to enhance confidence in the integrity of the Trust's processes and procedures relating to governance, risk management and internal control, and corporate reporting.
