# Being in charge of your own medicines Self administration scheme



Self administration is a scheme that allows you to take your own medicines while in hospital instead of waiting for the nurse to give them to you. It is an opportunity to increase your knowledge about your medicines and how to take them.

We aim to make sure that you know how to take medicines safely, and will help you understand more about your condition and general health.

Before you take part you will be able to talk with your nurse/midwife or pharmacist about self administration and the ways that it can help you. Self administration is not compulsory and you do not have to take part if you do not wish to.

A trained nurse/midwife or pharmacist will speak to you soon after admission to hospital and will explain which medication you will be taking, the doses you need to take and any potential side effects.

Where possible, your own medicines from home will be used. Further supplies will be provided from the hospital pharmacy if they are needed. You will be given a key to your medicine locker and asked to sign for the key. It is your responsibility to ensure that your medicines are locked in the medicine cabinet. You must give the key back when you leave hospital.

**Always** stick to the doses on the bottles – never take more.

**Always** check the medicine if for you – your name should be on the label.

If you forget what medicines you have taken or if you have any questions, then please talk to your nurse/midwife or pharmacist.

If any visitor or patient tries to take your medicines, please call a nurse/midwife at once.

Remember, medicines can be dangerous if not used properly.
