With reference to your request for information received on 14th October 2023, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

I am writing to make a request under the Freedom of Information Act for the Trust's official policy for a) reporting and b) recording of sexual safety incidents, including sexual abuse, sexual harassment or sexual assault through the National Reporting and Learning System (NRLS) or any other relevant system.

This request follows a statement by Minister Caulfield during a debate in Westminster Hall/House of Commons on 16 May 2023 "Abuse and Sexual Assaults in the NHS: Investigations":

"Data is important, and data on sexual safety is being recorded. We can see that through the national reporting and learning system, which takes all the data from local datasets. Where local risk management systems from trusts around England are reporting in, that is fed through to the national reporting and learning system, so that we have oversight of the scale and types of problems that are being seen."
