Dear Sir/Madam

With reference to your request for information received on 1<sup>st</sup> February 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

**1. Can I have a structure chart for the Procurement department at Sherwood Forest Hospitals please. Can this include name, job titles and contact details if possible.**

Section 21 exempts information that is reasonably accessible to you by other means.

The information you require is available here: <https://www.sfh-tr.nhs.uk/media/kw3f34ax/foi-53396-procurement-commercial-team-accompanying-document.pdf>

Names, job titles (other than that of our board of directors) and email addresses constitute personal data.

Section 40(2) provides that personal data is exempt information if one of the conditions set out in section 40(3) is satisfied. In our view, disclosure of this information would breach the data protection principles contained in the General Data Protection Regulations and Data Protection Act 2018

In reaching this decision, we have particularly considered:

- The reasonable expectations of the employees given their positions; Sherwood Forest Hospitals NHS Foundation Trust considered that none of the individuals would have a reasonable expectation that their personal data would be disclosed;
- The consequences of disclosure; and
- any legitimate public interest in disclosure.

Section 40(2) is an absolute exemption and therefore not subject to the public interest test.
