1. Background – Trust Standing Financial Instructions/Standing Orders

Under the terms and conditions of the Trust's Standing Orders and Scheme of Delegation the following categories require Trust Board of Directors approval:

- Use of the Trust's official Seal Standing Orders for the Board of Directors, Clause 12.2 Sealing of Documents
- Signing of Agreements and Documents Standing Orders for Board of Directors, Clause 13.2 Signing of Documents. Scheme of Delegation Clause 25
- Land and Property related documents: Scheme of Delegation Clause 25
 - a. Leases, including sub/under leases
 - b. Deed of Grants
 - c. Sales/Disposals
 - d. Acquisitions

Section 2 – Documents requiring Board Approval and Authorisation of the use of the Trust Seal (SO for BD Clause 12.2)

The Board are requested to approve the use of the Common Seal of the Trust in respect of the following document

a. Lease for the use of Northfield Car Park

Since completion of the construction of the new hospital and car parking provision, the Trust has in agreement with Ashfield District Council continued to use a portion of the Northfield site to provide a staff parking facility. The enclosed Lease requires application of the Trust Seal to formally complete the agreement.
