Dear Sir/Madam

With reference to your request for information received on 4<sup>th</sup> December 2023, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

**1. Do(es) your hospital(s) have a software system capable of patient radiation dose recording and management in radiology? (Note: this could be a stand along product or be part of a PACS or other radiology platform solution)**

Yes – Dosewatch and part of the PACS GE package.

**2. If so, is it a commercially available system or a system free of cost to use?**

This is part of the PACS system, and the Trust is unaware if it is commercially available separately.

However, if you are unhappy with the way in which your request has been handled, you have the right to ask for an internal review.
