

We have identified that details relating to, Level of amputation and Risk Factors will exceed the cost limit. For public authorities the cost limit is £450 (18 hours). If responding to one part of a request would exceed the cost limit, we do not have to provide a response to any other parts of the request. Therefore, the estimated cost of processing your request is £4,775.00. This charge has been calculated in accordance with section 13 of the Freedom of Information Act 2000 and the Freedom of Information Fees Regulations. In order to locate this information, we would need to review individual patient records for the last 11 years. We have identified 572 individual patients We have estimated that we can locate and review 3 patient records per hour. We estimate that the cost of
