In your request you asked:

**1. How many cancer appointments have been cancelled at your trust due to industrial action since 1<sup>st</sup> December 2022?**

56 total cancellations.

- **Which type of cancer had the most cancelled appointments and how many was that?**

Suspected head & neck cancers – 11 cancellations.
