Chair's Report – September 2020

Chair's reflections

I know what a busy time it has been for colleagues in SFH, and right across the system, and would like to reassure all of our colleagues that your wellbeing is of paramount importance to the Board, and we regularly have conversations to ensure that as an organisation that we are doing everything we can to support you as individuals.

Alongside this we know that more challenges lie ahead of us as we approach winter, continue to recover services from Covid-19, and move towards a clearer EU exit. I would personally encourage all colleagues to rest and recuperate where you can, and echo comments about making sure you are taking annual leave appropriately.

As we continue to follow guidance on social distancing, I have not been on site as much as I would have liked in recent months, but am hoping to be more visible in the near future. I continue to be busy in my role as Chair though, and the below report highlights some of where my focus has been during the last month, including an update from our most recent full Council of Governors, and I am also having ongoing conversations with Chairs in partner organisations about how we can work better as a system for the benefit of our citizens and colleagues.

Looking forward, I am pleased to see the annual Staff Excellence Awards are now open for nominations, and will look forward to judging the overall Chair's Award for Excellence, and would remind you about the upcoming SFH Annual General Meeting on Monday 28 September.

On behalf of the Board and myself, thank you for your hard work and dedication to our patients and community.

Council of Governors update

The most recent meeting of the Council of Governors took place on Tuesday 11 August, with a number of items identified to bring back to Board.

- Firstly, the Governors recognised the work and commitment of colleagues in response to the Covid-19 incident and acknowledged the next phase will be even more challenging as services are restored. They also reflected the need discussed above to pay attention to the wellbeing and welfare of colleagues.
- It was also the first opportunity for COG to officially welcome the positive CQC assessment for the Trust that was announced in May
- CoG approved changes to the Constitution and these will be presented at the AGM for final approval



There were positive comments in relation to the working of Board sub-committees. It was recognised that for some other key meetings that colleagues are struggling to find time to attend them (including Learning from Deaths, and there was a conversation about the clarity of the Terms of Reference for some of the cabinets which have been created.

It has been an extraordinary year for colleagues at Sherwood Forest Hospitals and the NHS. We want to ensure SFH's colleagues are recognised for the outstanding care and delivery of services not only throughout the Covid-19 pandemic, but throughout the year too.

This year there are 22 awards on offer to teams and individuals in all roles across the Trust, including several new Covid-19 specific categories that recognise colleagues' commitment, outstanding care, sacrifice and support during the pandemic. Sherwood Forest Hospitals commended for continuing much needed service for mums during the pandemic

Sherwood Forest Hospitals' Infant Feeding Team has been commended by the leading charity for children, UNICEF BFI, for their good practice throughout the Covid-19 pandemic.



Following the pandemic and the clear need to still help new parents with breast feeding their newborns, the team set to work and adapted their services to ensure they could still provide care to families in need.

Non-essential home visits were suspended locally on 17 March 2020, with many onsite clinics and face to face appointments being moved to telephone consultations and appointments. However, the Infant Feeding team at Sherwood Forest Hospitals did everything they could to ensure that breastfeeding infants who needed clinical assessments or treatment for tongue tie could be seen face to face either in the community or hospital setting.

The Team - which comprises of two Specialist Midwives and six Healthcare Support Workers ensured that the tongue tie clinic continued with adaptations including communicating with women before the appointment, hygiene measures and use of PPE. They also managed to run the clinic by undertaking assessments prior to the appointment in the clinic. The team's Health Care Support Workers are trained to assess for tongue tie, so they were able to assess some babies at their midwife postnatal clinic appointment in the community or at home, which helped avoid unnecessarily bringing babies into the hospital.
