Chair's Report - November 2020

Chair's reflections

Everyone will be aware of the increasing pressure on NHS services since our last Board meeting. We are now in a second surge of Covid and our hospitals have been treating increasing numbers of patients. The local infection and hospitalisation rates have led to Tier 3 (very high) restrictions being put into place in all parts of Nottinghamshire from Friday 30 October.

We have confidence that the Trust and our community will respond to these measures appropriately, but we fully understand that this will be a real challenge for everyone in their personal and professional lives after a long and hard year. We will get through this period together, but we would ask everyone to keep looking after themselves and each other. The Board regularly focuses on what we are doing to look after the wellbeing of Sherwood colleagues and we will continue to provide that challenge.

We recognise how hard colleagues are continuing to work, and we thank them for everything they are doing. I wrote to all SFH colleagues and volunteers at the end of October on behalf of the Board expressing our gratitude for everything they are doing and to offer our support. You can see a copy of that letter here.

Colleagues may have seen national conversations about a possible Covid vaccination programme. There isn't anything that we can update on here, but we will continue to support any activity as appropriate.

As we enter into winter, I think we are well prepared, but appreciate it will not be easy. Myself and the other Board members have not been as visible as we would normally be this year for obvious reasons, but we are looking at how we can make our presence felt more in the organisation, and I am available for anyone who wants to contact me.

We want to keep recognising the fantastic care and the many successes in the organisation as well, and I'm really pleased that our Annual Staff Excellence Awards are taking place tomorrow (Friday 6 November). We are having to run them virtually this year, but I understand there are plans in place to make the event as interactive and rewarding as possible. My thanks to everyone involved in pulling this together.

I would also like to express thanks for all colleagues who have taken part in the flu vaccination programme, and who have taken the time to have their say in the annual staff survey. We have had a very good response to both, particularly bearing in mind everything else that is happening this afternoon.



I was also pleased to watch the Trust's Public Broadcast and Question and Answer session on the evening of Wednesday 28 October, and was pleased that we also had representation from the Integrated Care System and from Healthwatch Nottingham and Nottinghamshire on the evening.

Finally, thanks to all of our members who voted in the recent Governor elections for a number of our constituencies. At the time of writing the results have not been announced, but I look forward to working with our new Governors.

Thanks again to all of our colleagues and partners for everything that you are doing.
