Dear Sir/Madam

With reference to your request for information received on 8th March 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold some of the information you have requested. A response to each part of your request is provided below.

In your request you asked:

- 1) The total £ amount spent on patient meals. I would like a figure for just the food / ingredients, without including staff costs or equipment.**
- 2) The total number of meals served to patients (including breakfast if possible)**
- 3) The average daily cost of meals per patient in £. I.e how much does it cost to feed one patient for a day, taking just the food / ingredients costs into account, so again not including staff costs or equipment. Provide this as an average over the year, along with a note on the method used to work this out if possible.**
- 4) The average number of patients you fed per day over the year (i.e on any given day we fed an average of 100 patients)**

The contract for this service falls under the Private Finance Initiative (PFI) contract held by Central Nottinghamshire Hospitals and their hard and soft services providers. The cost of these soft services are covered within the total unitary charge payment under the Private Finance Initiative for all services and as such cannot be separated as an individual cost as the contract is interdependent.
