With reference to your request for information received on 16<sup>th</sup> August 2023, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

Previous Request – 53092 - I'm trying to get a sense of how widely used paper notes are in the NHS currently. Would you be able to confirm if:


- paper notes/drug charts are used anywhere in the trust?
- if so, are there any plans to migrate away from paper to electronic? if not, how often is the decision reviewed?
- if so, does the trust keep track of serious incidents etc related to paper specifically eg misreading of handwritten comments/doses
- if not, how long ago trust migrated away from paper notes?
- 1. Please could I clarify the answer to question one.
  - Are drug charts paper, electronic or both? and
  - are notes paper, electronic or both?

Depending on the area, drug charts are either paper or electronic, but not both.
