With reference to your request for information received on 12<sup>th</sup> July 2023, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

**A copy of any analysis your trust has made of the impact that industrial action this year has had, or is likely to have, of the trusts ability to meets its elective recovery targets.**

Sherwood Forest Hospitals are compliant with Industrial Action submissions to monitor the impact on elective activity by way of cancelled activity.

No further analysis is undertaken regarding the impact this is having on our ability to meet elective recovery targets. The number of elective cancellations we have experienced for each month for industrial action (combined Junior Doctor and Consultant for the month of July) is as follows:
