	In order to locate this information, we would need to review individual cases for the last 5 years. Just based on the coroners investigations there would be 478 cases to review. We have estimated that we can locate and review 4 cases per hour. We estimate that the cost of satisfying your request will be £2,987.50 (478 x 15min = 119.5 hours, 119.5 hours x £25 per hour).
	Under section 16 of the Act we are obliged to advise you to refine your request to narrow the scope in order to bring it within the appropriate limit. Can we suggest that the timescales for question 3 are reduced, for example, to a calendar month. If the timescales are reduced to
