With reference to your request for information received on 17<sup>th</sup> January 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

- 2) Are A&E clinicians and nurses employed by the Sherwood Forest Hospitals NHS Foundation Trust trained to treat patients suffering with sodium nitrite poisoning with the antidote methylthioninium chloride commonly called methylene blue? Yes.
- 3) Does the A&E department at the Sherwood Forest Hospitals NHS Foundation Trust routinely carry the antidote methylthioninium chloride commonly called methylene blue?
