### **RE: Freedom of Information Request**

Dear Sir/Madam

With reference to your request for information received on 8<sup>th</sup> March 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

- Does your organisation provide substance misuse services? The community drug and alcohol service, Change, Grow, Live (CGL) employ the DALT team (Drug and Alcohol Liaison Team) to provide a drug and alcohol service to inpatients at Kings Mill Hospital.
- 2. Does your organisation have a policy on prescribing Take-home Naloxone for patients prescribed or taking opiates or opiate substitutes? Kings Mill Hospital has an Opioid guideline (hospital intranet) which explains how to initiate opioid substitutes to patients, how to check if the patient is already prescribed an opioid substitute and when Naloxone can be prescribed and dispensed.

I trust this information answers your request. Should you have any further enquiries or queries about this response please do not hesitate to contact me. However, if you are unhappy with the way in which your request has been handled, you have the right to ask for an internal review.
