Extended preparation prior to colonoscopy

Evening appointments

For a colonoscopy to be effective it is essential that the bowel is adequately cleansed prior to the procedure. A number of people will require additional preparation prior to colonoscopy, including laxatives and prolonged dietary restrictions leading up to the procedure. People who have constipation or diabetes, take medications which prohibit effective bowel cleansing and have had previously failed attempts at colonoscopy due to poor results from standard bowel cleansing will benefit from additional preparation.

It is important that you follow the guidance below starting seven days before the date of your procedure to aid effective bowel cleaning prior to your appointment.

Laxido supplied – ten sachets (if not received please contact Endoscopy unit).

Seven days before	Stop taking iron medication if you take them.		
Five days	Follow the low residue diet guidance found with your bowel prep information.	Plus, two litres of water.	Take Laxido – one sachet am and one pm.
Four days	Follow the low residue diet guidance found with your bowel prep information.	Plus, two litres of water.	Take Laxido – one sachet am and one pm.
Three days	Follow the low residue diet guidance found with your bowel prep information.	Plus, two litres of water.	Take Laxido – one sachet am and one pm.
Two days	Follow the low residue diet guidance found with your bowel prep information.	Plus, two litres of water.	Take Laxido – one sachet am and one pm.
One day	Follow the low residue diet guidance found with your bowel prep information. No food after 9pm.	Plus, two litres of water.	Take Laxido – one sachet am and one pm. Take two Senna tablets (15mg) in the evening.
Day of your test	Continue clear fluids up until two hours before your procedure time. No food.	Continue clear fluids as instructed.	Take your first dose of Plenvu at 7am Take the second dose of Plenvu five hours before your appointment.



First dose of Plenvu taken at 7am the day of your appointment.

Second dose of Plenvu five hours before your appointment time.

Please follow the enclosed Plenvu leaflet.



No food for two hours before your appointment time.
