I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold some of the information you have requested. A response to each part of your request is provided below.

Could you provide a list of all NHS hospital at home or virtual ward available in your region as well as their email contact information please	We can only provide a list of virtual wards available at Sherwood Forest Hospitals, listed below: Frailty Respiratory OPAT	Yes	Section 40(2)	<p>Names, job titles and email addresses (other than that of our board of directors) constitute personal data.</p> <p>Section 40(2) provides that personal data is exempt information if one of the conditions set out in section 40(3) is satisfied. In our view, disclosure of this information would breach the data protection principles contained in the General Data Protection Regulations and Data Protection Act 2018.</p> <p>In reaching this decision, we have particularly considered:</p> <ul style="list-style-type: none"> <li>• The reasonable expectations of the employees given their positions; Sherwood Forest Hospitals NHS Foundation Trust considered that none of the individuals would have a reasonable expectation that their personal data would be disclosed;</li> <li>• The consequences of disclosure; and</li> <li>• any legitimate public interest in disclosure.</li> </ul> <p>Section 40(2) is an absolute exemption and therefore not subject to the public interest test.</p>

I trust this information answers your request. Should you have any further enquiries or queries about this response please do not hesitate to contact me. However, if you are unhappy with the way in which your request has been handled, you have the right to ask for an internal review. If you are dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office, who will consider whether we have complied with our obligations under the Act and can require us to remedy any problems. Generally, the Information Commissioner's Office cannot decide unless you have exhausted the internal review procedure.
