9. To measure Amniotic Fluid does your trust measure Deepest Vertical Pool or measure Amniotic Fluid Index?	For singleton pregnancies we use Amniotic Fluid Index For twin pregnancies we use Deepest Vertical Pool.			
10. Which chart do you use to plot the amniotic fluid volume?	Currently we do not plot AFI on a chart. We refer to a printed chart by Magann, E.F. et al. Am J Obst Gynaecol 2000; 182: 1581-1582. We then comment on whether AFI is normal, reduced or increased. In July 2025 we will be moving to a new reporting system Viewpoint V6 where the AFI will automatically plot on a chart. The reference for this is: Moore TR, Cayle JE. The amniotic fluid index in normal human pregnancy. Am J Obst Gynecol 1990; 162: 1168-1173.

When measuring Uterine Artery Doppler PI and PSV, Umbilical Artery Doppler PI and PSV, Middle Cerebral Artery Doppler PI and PSV, Ductus Venosus Doppler PI and PSV which reference centile chart do you use?	<p>Uterine Artery Doppler PI and PSV: Gomez, O et al.
