With reference to your request for information received on 6<sup>th</sup> February 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

- 1. For each Trust, please can you provide all Food Hygiene inspection results/reports, details of subsequent enforcement actions taken, and all supporting documents relating to the inspection and any subsequent actions.**
  - I am primarily interested in the main Trust hospital, or hospitals, but if there are inspection reports from other sites managed by the Trust, please provide these as well.
  - Please can you provide all the information, reports, and documentation, going back three years.

Section 21 exempts information that is reasonably accessible to you by other means. The information you require is available here: <https://ratings.food.gov.uk/>

I trust this information answers your request. Should you have any further enquiries or queries about this response please do not hesitate to contact me. However, if you are unhappy with the way in which your request has been handled, you have the right to ask for an internal review. If you are dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office, who will consider whether we have complied with our obligations under the Act and can require us to remedy any problems. Generally, the Information Commissioner's Office cannot decide unless you have exhausted the internal review procedure.
