Please note: the above information relates to the number of unique patients who were prescribed a biological medicine and also had an inpatient spell between the requested dates.

Additionally, we have extracted records based on ICD10 coding in any position within the patient's record. This means that the diagnosis is not necessarily the primary reason for admission.

We cannot say if the drug in question was used to treat a specific diagnosis; only a clinical review will confirm that. My extract only indicates that the drug was issued to the patient and the patient was discharged from an inpatient spell with the requisite diagnosis codes within the requested time period (January-March).

I trust this information answers your request. Should you have any further enquiries or queries about this response please do not hesitate to contact me. However, if you are unhappy with the way in which your request has been handled, you have the right to ask for an internal review. If you are dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office, who will consider whether we have complied with our obligations under the Act and can require us to remedy any problems. Generally, the Information Commissioner's Office cannot decide unless you have exhausted the internal review procedure.
