Membership and engagement group Quarterly report

January 2023

1 Background

Over the past two-and-a-half years the focus has been on member engagement as opposed to recruitment. A conscious effort has been made to collect more member email addresses in order to streamline member communications, with members being given an opportunity to identify their preferred methods of communication and engagement, either through active or observing member status.

Work has been ongoing to build representation and increase engagement in the 16-22 years age group with collaborative working links being forged with local colleges and education providers, as well as an upcoming 'Step into the NHS' event as it has been noted that members aged 16 to 25 make up just 1% of the trust's membership (128 members).

2 Member communications and engagement

2.1 Member engagement

Sue Holmes and other Governors have been handing out NHS careers books at MYG events and other external events they have attended in order to encourage youth membership. The youth forum has been reinstated, with a member of this forum currently working in the comms team. This will give the team valuable insights into the thoughts and feelings of local people in the 16-25 age bracket and aid the team to come up with a strategy to further increase membership in young people within the area.

The Trust recently signed a compact with West Nottinghamshire College where they agreed to work collaboratively in order to give training, education and employment opportunities to local people and have also been featuring weekly on the 'NHS Show' which is broadcast on Mansfield 103.2. All of the above will increase awareness of the Trust within the local population.

2.2 Member communications

Trust Matters continues to be sent electronically to members monthly. The average open rate is around 38%. This figure was 19% in the last quarter.

3 Representation

The current public membership total stands at 14,102, which is a decrease from last quarter, which stood at 14,194.

Overall analysis of gender, age group, ethnicity, socioeconomic groupings and constituencies revealed the following:



- Gender Males are still the most underrepresented gender with a total of 4994 male members across all constituencies.
- Age group 16–21-year-olds are the most under-represented age group. The total number of members in this category is 50. This is an increase of 17 from last quarter
- Ethnicity Members of mixed ethnicity are currently the most under-represented with a total of 30 members from this category.
- Analysis of membership by constituency shows that the most under-represented areas are, Out of Trust Area and the Rest of England.

Current breakdown by area is:

4,306 – Mansfield (lq:4,322)

4,187 - Ashfield (lq: 4,205)

3,276 – Newark and Sherwood (lq: 3,295)

2,191 – Rest of East Midlands (lq: 2,208)

17 – Out of Trust area (lq: 40) 125 – Rest of England (lq: 124)

4 Membership forward plan

As stated, the current focus for communications is on operational issues relating to the current surge in Covid-19 cases in the community and the subsequent increase in admissions to our hospitals. There is, however, an acknowledgement that the Trust needs to continue with its wider stakeholder and partner engagement as soon as practicable.

The next edition of Trust Matters is scheduled to go out 6 January 2023.
